INVITATION OF BIDS FOR SALE OF DIPLOMATIC CAR

1. The High Commission of India, Port Moresby, invites sealed bids from interested organizations/individuals for the sale of **one diplomatic vehicle on an "AS IS WHERE IS BASIS"**, subject to the terms and conditions stipulated in **Annexure-I**.
2. **Inspection of Vehicle:** The vehicle will be available for inspection on working days from **10 September 2026 to 21 September 2026** (excluding weekends and closed holidays), between **1000 hrs. and 1600 hrs.**, at the **High Commission of India, Section 07, Lot 30, Lawes Road, NCD, Port Moresby**.
3. **Submission and Opening of Bids:** The last date and time for submission of sealed bids is **24 September 2026 at 1730 hrs.** The bids will be opened at **1500 hrs. on 28 September 2026**. Bids received through **email or fax** or submitted in an **open/unsealed envelope** will be **summarily rejected**.

Terms and Conditions:

- 1) The bid shall be submitted in a **sealed cover**, clearly superscribed "**Bid for Auction of Diplomatic Car**", and addressed to: **Head of Chancery, High Commission of India Port Moresby**. The last date for submission of bids is **24 September 2026**.
- 2) The sealed envelope submitted by the bidder shall contain the following: General particulars of the bidder, along with the **bid amount quoted in Kina**, clearly indicated **both in figures and in words**. The bid shall remain valid for a minimum period of **90 days from the last date of submission of bids**.
- 3) Bids received through **email or fax** or submitted in an **open/unsealed envelope** will be **summarily rejected**.
- 4) The vehicle shall be sold to the bidder quoting the highest acceptable bid. Upon being declared the successful bidder, the bidder shall deposit 50% of the accepted bid amount immediately by bank transfer. The relevant bank account details will be communicated to the successful bidder. Upon final acceptance of the bid, the successful bidder shall deposit the remaining 50% of the bid amount, together with applicable taxes and statutory charges, if any, within one week from the date of communication of acceptance of the bid. Failure to deposit the balance amount within the stipulated period shall result in forfeiture of the 50% amount already deposited.
- 5) The vehicle shall be handed over to the successful bidder only after receipt of the full amount payable and completion of the necessary documentation/formalities. The successful bidder shall make his/her own arrangements, at his/her own cost, for taking delivery of the vehicle.
- 6) Conditional bids shall not be accepted.
- 7) It shall be deemed that the bidder has inspected the vehicle and satisfied himself/herself as to its condition before submitting the bid. The vehicle is being sold on an "**AS IS WHERE IS BASIS**", and the High Commission of India shall not be responsible for, nor entertain any complaint or claim in respect of, any defect, deficiency or condition of the vehicle after the sale.
- 8) Officers and staff members of the High Commission of India, Port Moresby, and their family members shall not be eligible to participate in the auction.
- 9) The successful bidder shall be solely responsible, at his/her own cost, for transfer of ownership, registration and completion of all other formalities relating to the vehicle in accordance with the applicable rules and regulations. The High Commission of India shall not be responsible or liable in any manner for registration or transfer of the vehicle after its sale.
- 10) The High Commission of India, Port Moresby, reserves the right, at its sole discretion, to accept or reject any or all bids, at any stage, without assigning any reason whatsoever.
